

For example: Different slogan and message are written in many walls in simple language so that people can read, understand and share with other about the message and slogan. <u>Outcomes</u> 1553 wall writing has been written in 146 villages.

Rally/Foot march

The disability rally right movement is the most important part because the rally is all about the equal rights and opportunity for the people with disabilities and to access with similar goals and demands for the people with disabilities. Therefore On 1st October 2018 people with disabilities rally have been organized at Surajpur district. People with disabilities were participated from different field area of MSS included DPOs members and leaders about disabilities rights,

reservation, pension and inclusive education. 200 People with disabilities were participated. **Outcomes**: Through CDJF given a letter to District collector of surajpur district regarding people with disabilities demand such as: 4% reservation should be implementation in govt. and private sector, state level ministry for promote people with disabilities, Appoint people with disabilities lok pal in each district, inclusive school at block level and pension should be increased up to 3000 rupees.



World Disability Day celebration

The importance of World Disabled Day is promoting an awareness of disability issues and fundamental rights of persons with disabilities. It is important to integrate disabled persons in the main stream of society. Because the day was greatly emphasized to celebrate it yearly in order to promote the awareness about the people with disabilities as well as to encourage them by implementing a lot of assistance in their real life to enhance their way of life and remove the social stigma towards them.

Likewise, every year in this year 2018 on 3rd December Margdarshak Seva Sansthan again celebrated the International day of disabled persons at Ramanuj Nagar situated in surajpur

district. The vital purpose of this day celebration is to improve the understandings of the people with disability issues as well as get together to support them to improve their selfesteem, well-being and rights in the society. It also looks for to involve all the society in each facet of life such as the political, economic, social and cultural as well as livelihood, assessment, rights and entitlement, disabilities inclusion, women with disabilities, Promote dignity, Mainstream disabilities, reservation, ensure equality, social policy, empowerment, inclusive education, skill training, leadership training, linkages with them various govt. 1133 **People** disabilities with were participated.





Block level PRI training

Block level PRI training improve the capacities building of PRI members regarding RPWDs act and policy 2017 implementation procedure at panchayat level. Because lack of knowledge amongst PRI members about rights and policy of the people with disabilities. MSS empowered PRI members about people with disability; therefore organized block level

P.R.I meeting at block level. The executive director of MSS Mr. Mehdilal expressed about Rights of Persons with Disabilities Rules, 2017, Rights of persons with disabilities Act 2016 implementation amongst people with disability. Discussed about them different issues relate people with disability like: certification, pension and because many people

with disability were still not getting certification andpension. For that reason people with disability were facing trouble day by day for their daily living activities. Even he expressed pension and PDS to Janpatpnchayat. At lastly, discussed about medical certification

camp for people with disability at block level. **Outcomes:** Every Panchayats will write an application regarding pension, certification, PDS to Janpatpanchayat for people with disability.





CBR Committee formation

CBR committees consists of 2 DPOs members, 2 PRI members, 2 ANMs workers, 2 parents, 2 teachers, 2 AWDs, 2 SHGs members for promote people with disabilities with different issue related certification, pension, employment, livelihood, reservation, scholarship, assistive device, enrollment

of people with disabitlies at panchayat level. Because through CBR committee people with disabilities directly cosult with CBR committee team members for different issue. Outcomes: Total 58 CBR committees have been formed with 642 members.

Inclusive school competition specially focus on children with disability and children without disability about improvement their participation, skill, confidence level in each and every activity at school like: quiz competition, debate, drawing competition, rangoli competition, and sports competition like: Football, cricket, volleyball and badminton and in order to reduce discrimination between children with disability and children without disability. <u>Outcomes</u>: formed 100 inclusive children club.



Need based skill training on livelihood for establishment microenterprises for self dependency

MSS organized certain training and program on sustainable and secure livelihood opportunity for underprivileged people in community. For the development of livelihood for community people as well as people with disability, we made certain livelihood planned for people with disability as per their family condition, economic condition, property, any other out income sources even their social, political and cultural status in community. All these aspect will help for making livelihood planed especially for people with disability.

And those SHGs group of women are belonging to poor family and their income sources is very low they have no other out income sources for included women with disability all these reason MSS gave them skills training like: Mushroom production, tailoring training, General Merchant, Dona patta, vermin compost training, Cycle repair, animal husbandry, through Income Generation Program (IGPs) of MSS. <u>Outcome:</u> 343 people with disabilities were access skill development









Medical certification camp for People with disabilities

Every 2nd Wednesday and 4th saturday of month medical certification boards camp has been organized in surajpur district hospital and every saturday and Friday of month medical certification boards camp has been organized in Ambikapur.Through medical certification

camp of district hospital surajpur people with disabilities were check their physical treatment as well as 40% of disabilities certification through the support of health care provider and CBR workers. **Outcome**: 1284 people with disabilities access medical certification.

physical exercise. **Outcomes**: 232 children with disabilities access physiotherapy.

Some members were shared their plan about what they do in future SHGs. How will continuing it forsustainability period. The director of MSS expressed them about how to work together insocially, politically and economically. Then expressed improvement of SHGs income sources about regular monthly saving, bank credit, interest and loan it means through regular monthly meeting, participation of active members, maintain registers, passbook updates. Organize SHGs meeting with included women with disability, planning, monitoring process and how to we go fast to reach our goal. Some SHGs members were told about how SHGs help for them like: if someone or any women with disability wants to need money for treatment,

marriage or other purpose of business SHGs will help them. Those SHGs really wants to need financial support through Income generation program like: Mushroom production, tailoring, general merchant and fishing they make their plan. Some SHGs members were expressed their plan like what they want to do like: chicken cultivation, prepare leaf plates, make candles and smoke stick. Even those SHGs were going under

I.G.P for mushroom production. MSS will provide mushroom seeds as soon as possible because it's seasonal business. Even discussed about how to SHGs members were. **Outcomes**: 2 SHGs training has been organized with 44 members about inclusive participation of women with disabilities about economic development of poor and marginalized women in the society.





Formation and strengthening DPOs federation

DPOs are representative organization or group of person with disabilities where people with disabilities constitute a majority of the overall staff, board and volunteer in all level of the organization. DPOs federation importance role and responsibility of all people with disabilities those who are leaving in community. Through DPOs federation organized meeting with DPOs members about formation and strengthening D.P.Os federation at panchayat level, Rights of Persons

with Disabilities Rules, 2017, at panchayat level. Aware about support poor and marginalized people with disability those who does not have other income sources for livelihoods. Then discuss about benefits of panchayat level D.P.Os federation through formation block and district level D.P.Os federation procedure also discussed about process of monthly meeting. DPOs members were participated. **Outcomes:** 39 DPOs federation has been formed with 256 members.

Major responsibility of Panchayat level D.P.O Federation is if any people with disability need to be financial

his/her economic support according to condition in that situation only the federation will decide who want to be need support as a first priority. Then expressed about **Process of** level **D.P.Os** formation: block Then expressed about Process of District D.P.Os formation: From each block 5 members will go to District level D.P.Os federation meeting included President. Secretaries with 3 members and for formation of district level D.P.Os federation add 5 members from each block. At state level D.P.Os federation formation process will be organize in next month with 5 selected members from District level.

<u>Outomes</u>: 2 District level DPOs federation has been formed with 57 members.





State level DPOs meeting

The resources person of the meeting was Mr. Mehdi lal explained that according to census data of Govt. of. India the total population of people with disabilities is 2.50 corers in India apart from that state govt. data 649000 people with disabilities in 27 district of Chhattisgarh. But still people with disabilities are not getting their basic rights like: food, shelter, health, education, livelihoods. reservation and employment. Also spoke about social, political, economical people with disabilities is very weak because socially people with disabilities discrimination in between society and society will never accept and not good

with disabilities. thinks about People Politically local leaders, community leaders are not support to people with disabilities for participation in election and elect leaders. Then Decided write a letters to MLA for support VJF as socially, politically and economically. Total 3 state level DPOs meeting have been organized with 97 (Male-56, female-41) members were participated from 10 districts. **Outcomes:** 100 rupees membership fees for all DPOs members included block, district and state level CVJF leaders. And decided 1 leader should be lead 50 people with disabilities





CBR Training for Project Staff

This year organized Staff training on CBR and People with Disabilities Act 2017 and policy. In this training trained them about MANREGA and its various schemes as well as inclusive participation in MGNREGA, the process of implementation of RPWDs act in community level through various awareness meeting, individual responsibilities, and contribution per organization, dedication, improvement of presentation skill,

knowledge, attitude, behavior changes, self confidence, and self respect. Total 1 training has been organized about implementation procedure of MANREGA various schemes. Total 190 staff members were participated included (Male- 155, female-35). **Outcomes:** Staff members aware about MGNREGA various schemes and its provision.





Capacities build training for youth

Organized youth training at Maati resource centreKataroli Village. The key person of that meeting was Mr. Mehdi Lal, Director of MSS. In that training discussed about various types of issues related youth's rights and livelihood, social, political, economical and cultural development. Even trained them about survive for self dependency, self reliance, self esteem and make their good image in society. Train them through various

exercises, group works and aptitude tests. Also discussed about the social, cultural, political and economical participation of youths even skills development among youths to stand as a responsible person in society, taught them about good leadership quality, all these aspects will make them become a well established. **Outcomes:** 8 youth has been selected for field staff.









Deforestation clearing is the removal of a forest which is then converted to a non forest use. Deforestation can involve conversion of forest land to farms ranches or urban use. It occurs for several reasons trees can be cut down to be used for building or sold as fuel. The removal of trees without sufficient reforestation has resulted in habitat damage biodiversity loss, and aridity. Then

it traditionally is based on the area of forest cleared for human use including removal of the trees for wood products and for croplands and grazing land. In the practice of clear cutting, all the trees are removed from the land which completely destroys the forest in some cases. 2018, through the department of forest area of Morgacutting of forest

Forest right Act 2006 CFR/IFR

The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 is a result of the protracted struggle by the marginal and tribal communities of our country to assert their rights over the forestland over which they were traditionally dependent. The implementation of the Forest Rights Act, 2006 on 1st Jan 2008, has finally paved the way to undo the 'historic

injustice' done to the tribal's and other forest dwellers. Individual forest right act 2006, people were aware about their rights of forest, land, wild food, conservation of natural resources through awareness meeting on CFR/FRA/IFR. In 2018, 2 village level CFR has been approved by Gramsabh and 32 IFR has been approved by gramsabha

Case study



Situation before the changes

• This case is belongs to 28 years old man who is having physical impairment, his name is Thakur ram son of Puran sai from Salka village under Premnagar block of Surajpur District. He has 6 family members included 3 small brothers. His family members are dependable on agriculture.

• What happened and why

The reason behind of his disabilities is while he was 12 years old, his legs begun paining then after few days slowly he was suffering polio diseases. After treatment of his diseases it's not cured. He also has not completed his higher education Because of financial problem. Through the support of Local bodies leader (Sarpanch) Mr. Chandan singh and through Department of social welfare provided Tricycle for his accessibility. Through this he is able to do his daily activities.

• What is the situation now

Now a day he engaged in economic activity just like General merchant. He Earned 100-150 rupees per day. He is doing 8 to 12 hour duty in his shop. He is very satisfied though his business. Because he is getting self respect through community people with this his brothers also help him in his business.

• What is the main causes of changes

Since 2012, he has been identified by CBR worker through the survey of MSS. According to his poor economic and family condition MSS provided financial support for Income Generation Program (IGPs) i.e. General merchant worth rupees 10,000 by CBR worker on 2016.

• What are the last challenges

- o His biggest challenge is management of financial status of shop.
- What are the effects of changes?

• What we learn from this story

The future of MSS

MargdarshakSevaSansthan has successfully completed its 21 years of developmental interventions in Chhattisgarh.

Previously MSS has done mostly work as a Facilitating and training team at community level in six district of Chhattisgarh for underprivileged women, children and people with disabilities and Non people with disabilities.

Focus areas of future works with communities on a broad range of development & strengthening initiatives. the main focus of the program is on community mobilization and mass awareness campaign to sensitize community on disabilities., removing stigma and barriers, income generation program for their livelihood, capacities building of people with disabilities family member, organization of medical screening, health camps, certificate and support services eg; certificate, bus pass, pension and training for the school and Anganwadi teacher on inclusive education. We are also in collaboration with banks, District Magistrate, state govt. and central govt. for reservation and rights of people with disabilities in different govt. sectors and private sectors.

We are also focus on women in future about empowering their dignity, liberty, rights, equality, No Gender discrimination, education and health. Involve them in Social activities, social action for justice against women domestics violence and women trafficking. Engage them in various income generation activities and Skills development training and leadership qualities. Also we are empowering women reservation so they become self employment, rise in income level, better standard of living, self reliant and poverty eradication in future.

In future we will cooperate with tribal society about their forest conservation, natural resources and wild food. To preserve forest products and wild food for good entrepreneurship with local poor people for their improvement of rise in income level and livelihood in well establishment in society. So as to facilitate awareness meetings about to stop cutting of forest and natural resources, Rally and street play. Also we are focus on forest rights Act, Community forest right Act, Individual forest rights Act, legal rights and PESA Act.



For children we are planning about their health, education and other skill development program and Aptitude test. Also will organize sports event and give training them about importance of

Forest and natural resource and will organize health camps. MSS Grateful to the agencies, individuals, cooperate sectors and govt. those who support for improving the quality of life of the marginalized people with whom MSS has been working for last 21 years.
